#### **Update by Leon Ward -**

**Leon** received an email regarding Lyte Fiber placing fiber optic cable within the ROW's of Oak Valley. The email was requesting information on required permits.

Max suggested that we **table** this topic until next month. He will speak to other towns about ordinance pros and cons. May need a special meeting.

## Road/Bridge Maintenance Update

Commissioner David Brewer had to leave to take care of downed trees due to a sudden storm that came up during the meeting. Max asked him if he had a timeline for work on the end of Liberty Dr. David said hopefully the last week of August or the first week of September. They plan on bringing both asphalt zippers.

# Re-Building of Oak Valley Thoroughfares Update

 Discussion of Amending the Road Construction Project Max - Randy Burkey, Kendall Walker and Max Taylor met with Commission David Brewer on unofficial business. Tried to come up with a game plan that we're not regretting 2 years from now with more pot holes. A plan could be for the County to pull off building any more roads for us except to address the front part of Liberty Dr with drainage problems and the section just past the bridge with no pavement. Commissioner David Brewer said hopefully they will take care of those areas the last week of August or the first week of September. They plan on bringing both asphalt zippers. Randy - Liberty Dr from city limits to 1100, needs to have the surface milled up, put down flex-base and grade it. He has had conversations with others in the asphalt business and they agreed that the base was not stabilized. The longer it sits in flex-base (1-2" road base) and gets traveled and compacted the base will be more solid. The county will need to maintain from time to time with the blade and smooth it. Max - for the County to fix Oak Valley Ln, they will need to remove parts of the asphalt. The materials needed to fix it will come out of our funds.

After this, we will revert back to our original Interlocal Agreement and put off road re-construction until we know, without a doubt, that we will receive franchise fees. Then we can get a road loan to go ahead and begin work.

Max - This is the proposed reconstruction plan. When we know what month of kilowatt (kW) hours we will start being paid for, then we will send out for formal bids. Randy - They may need to do core samples to check the compression rate on the base.

Max - If it takes a year before we can get a road loan, the County has offered to come out 4-5 months before to do the remilling of the existing road base. The road construction company can also do this, but would cost more than the County. We can discuss closer to time.

Randy - It may actually be more cost effective to have a road construction company do it to get it done in the right timeline in case the County is delayed.

Max - While the professional company does the main roads, the County could be milling the side roads.

Randy - Once the County does Liberty Dr, any time they can come, turn them loose on the side roads to mill and grade.

**Debbie Taylor** asked if the County could do the walking track. However, the walking track is considered on private property so the County is unable to do that.

Motion made by Randy Burkey to stop the road construction by the County after they have fixed areas on Liberty Dr and by the bridge, then we will pick up the road construction once annexation is approved. Seconded by Leon Ward, carried and approved by majority vote.

#### **Commerce Report:**

• Planned Annexation Update, Mayor Max Taylor
Riot Platforms has signed the remaining document. They've agreed
to be annexed into Oak Valley and also be included in our ETJ. Our
next phase is we need to survey the ROWs in several areas.

Max has the name of a recommended surveyor, Shallow Creek Land Survey (Eric) to contact. Max sent him a list of what needs to be done. The attorney said the survey needs to be from fenceline to fenceline instead of the middle of the road out 10' each way and it has to be mapped. The surveyor will charge ~\$18-\$20K, and hopes to be finished by Sept 12th. This is great because every month we delay, we are losing Oncor fees. The sooner we submit our application for annexation the better. Our franchise fees will be calculated based on the date we submit our annexation request, not the date the Texas Comptroller approves.

- Code Enforcement Update, Mayor Max Taylor
   Regarding 648 and 650 Oak Valley Lane waiting on the tax attorney (Linebarger Goggan Blair & Sampson, LLP) but she has filed. The process could take ~6 months to a year.
- Relinquishment of Authorized Agent Delegation Order, Mayor Max Taylor

Motion by Randy Burkey to approve the Resolution of the Board of Alderman of the Town of Oak Valley, Texas for the OSSF Relinquishment Order of the Town of Oak Valley, effective July 1, 2025, regarding the relinquishment of authorized agent delegation to the Town as ordered by TCEQ's Executive Director. The motion was seconded by Kim Ogden, it carried and was approved by majority vote.

# **Volunteer Fire Department Report:**

**Max** spoke to **Jeremy Cobb** (Fire Chief) a couple of weeks ago that we would like to help out the VFD with our expected Oncor franchise fee funds. The VFD meets on Thursday of this week. Max reviewed three documents with the Council.

- 1) Interlocal Agreement with Corbet-OakValley VFD

  Max read the proposed Interlocal Agreement he presented to Jeremy

  Cobb pending Alderman approval. If we provide funds, they need to
  agree to be annexed.
- 2) Post Card The VFD meets Thursday and if they sign the Interlocal Agreement, we also need them to help us increase our ETJ area. The Post Cards will go out Friday or Saturday.
- 3) Letter to all landowners that qualify to be part of our ETJ all residents in Oak Valley are already in our ETJ. No surveys required as in annexation, the resident just signs a petition requesting to be in our ETJ and its notarized. The letter will go out around Monday.

**Kendall Walker** asked if there would ever be a reason for an audit to ensure the donated funds were being spent properly. Council discussed and decided that **Max** would add a condition asking for annual accounting from the VFD of where the donated funds were spent.

Motion made by **Kendall Walker** to approve submission of Interlocal Agreement pending signatures of Max Taylor, Kelli Burkey and VFD Fire Chief and that the VFD agrees to the accountability requirement that Max will add. Motion seconded by **Kim Ogden**, carried and approved by majority vote.

Max will send a copy out before he gives the document to the VFD.
